nis is a private transaction between the buyer and the seller for the purchase of a Standard Poodle as a pet only. No reeding is permitted.				
ne following are the terms and conditions of this contract.				
Price of the Standard Poodle. (1) The buyer agrees to the purchase of a Standard Poodle puppy for the total amount (USD) \$ to be paid to the seller before this contract is effective. A deposit of \$500.00 is required and the emaining balance must be paid upon delivery of the puppy. We do not ship puppies.	it			
Identifying information for the Standard Poodle puppy. (1) The buyer has chosen a Standard Poodle puppy with the ollowing characteristics:	e

Registration. (1) The seller guarantees this animal to be registered or qualified for registration with the American ennel Club.				
Health of the Standard Poodle puppy. (1) The seller agrees to deliver to the buyer a Standard Poodle puppy in good ealth with no symptoms of infectious or contagious disease.	k			
Veterinary Health Exam. (1) The seller guarantees that the Standard Poodle puppy has been determined as healthy licensed veterinarian and results of the exam will be given to the buyer. (2) The buyer agrees to pay for a licensed eterinary health examination and will obtain a copy of the results within three days (weekends, holidays do not coun taking possession of the puppy. (3) The buyer agrees to forward the written results of the veterinary exam to the eller. The terms and conditions of this contract are not effective until the seller has acknowledged receiving the result the exam. (4) The buyer agrees to assume any financial responsibility for this examination; veterinary expenses and/or medications are not covered in this contract.	t)			
Health Warranty. (1) The warranty period for this puppy is two years from This warranty overs fatal and life altering congenital diseases. This includes severe hip dysplasia, seizures, Addisons Disease, as well dney, heart, pancreas, spine and liver problems of a severe, life threatening or altering nature. The warranty does not over any common puppy ailments including but not limited to worms, coccidia and/orgiardia, vitamin deficiencies, easterions, any viral or bacterial diseases, or disorders brought on by parasites. (2) If the Standard Poodle puppy dies within this contract's effective period, the buyer agrees to assume financial responsibility for an autopsy on the puppy	ot ar			

to be performed by a licensed veterinarian to determine the cause of death. (3) Buyer agrees to forward the written autopsy report to the seller. (4) If the cause of death is found to be any affliction listed in the health warranty section (6.1) of this contract, the seller agrees to replace the puppy with one of similar identifying characteristics as those listed in the identifying information for the Standard Poodle puppy section (2.1) of this contract, unless characteristics are

unavailable to the seller or otherwise specified by the buyer. (5) Buyer agrees that there is no monetary refund of any kind, full or partial, guaranteed or implied. (6) The puppy must exhibit the congenital defect within the effective period of this contract. (7) The buyer agrees to notify the seller of the problem as well as furnish veterinary reports, on the veterinarian's letterhead with date and time of exam, by two unassociated licensed veterinarians stating the affliction within two business days of the problem's discovery. Buyer understands at time of purchase, that should they return the puppy, the seller has the right to contact the veterinarians (before the puppy is returned) that issued the reports for further verbal verification before determining if an exchange will be made.

- 7. **Health conditions.** (1) This guarantee does not apply to any afflictions caused by environmental factors. (2) The seller does not assume responsibility for any reaction to any vaccination. (3) The seller does not assume responsibility for any medical expenses incurred associated with any health problem. (4) This guarantee does not apply to any physical problems which could be the results of an injury.
- 8. **Puppy care.** (1) The buyer is responsible for and agrees to provide routine veterinary care for the puppy including age appropriate vaccinations and routine worm checks. Buyer will be asked to produce such records of care if buyer has to return the puppy for replacement. This contract will be null and void should the buyer fail to provide routine veterinary care records. (2) The buyer agrees to keep the puppy away from dog parks, grassy areas, pet stores, etc. until the puppy is at least 16 weeks of age and has received his/her final vaccination. (3) The buyer agrees to keep the puppy away from lakes, rivers, oceans and other areas of water where the puppy can be in danger of drowning unless proper safety protocol is followed. (4) The buyer agrees to provide adequate fresh water, quality food*, opportunities for exercise and rest to the puppy. (5) The buyer assumes responsibility for protecting the puppy from loss, theft, danger, neglect and abuse.
- 9. **Return policy.** (1) A puppy eligible for replacement, pursuant to section 6 of this contract must be returned or euthanized with prior permission from the seller to qualify for replacement. (2) The returned puppy must appear in good condition to the seller, other than the specified problem. (3) A puppy will not be eligible for replacement if it has been or appears to have been neglected, abused, bred or euthanized without prior permission from the seller. (4) The buyer agrees to assume financial responsibility for all transportation costs incurred for transporting the returned puppy to the seller.
- 10. **Dispute.** (1) This is the entire purchase contract; no other promise or stipulations are included or implied in this sale. (2) In any and all legal action pertaining to this dog, this contract shall be considered to be legally binding. (3) In the event of any dispute or disagreement under this contract, the laws of West Virginia will govern the resolution of the dispute and venue for resolution of any dispute will be in West Virginia. (4) To the extent that any provision of this contract may be invalid under any law of the state of the buyer, all remaining provisions remain binding.
